ICNDT Photograph Competition 2020 **“NDT Stories in Pictures”**

Guidelines

1. Win the prize of “One Free Full Registration” for the 20th World Conference on Non-Destructive Testing (WCNDT 2020) from 8 to 12 June 2020 in Seoul, Korea. The winner will be announced by the end of April 2020, and awarded during the WCNDT 2020 with a certificate of commendation. The deadline of this competition is 31 March 2020.
2. Accommodation, travel, airfare and any other expenditures are NOT included in this competition.
3. The competition is open for one photograph from one individual with completion of all forms required;
 - A) ICNDT Photograph Competition 2020 Application Form,
 - B) Photography Release Form,
 - C) Model Release Form.
4. The photograph must have a “Short title” or “Theme” with the maximum of 15 words, and related with NDT such as NDT site of research, inspection, evaluation etc. Overt advertising is not allowed and this would be best avoided by showing operational activity against an interesting background.
5. The photograph must be in digital format. No print or film submission will be accepted for entry into this competition.
6. All digital files must be 1 MB or larger, must be in JPEG or JPG format.
7. The photograph should be a minimum of 2,500 pixels wide (horizontally) or a minimum of 2,500 (vertical).
8. The photograph must have been taken within one year before the date of entry, and it must not have previously won any award in any other completion.
9. The photograph may be digitally enhanced to remove, but not manipulated. The picture may be enhanced to make it brighter, clearer etc., but the content must not be manipulated.
10. The photograph, in its entirety, must be a single work of original material taken by the competition applicant.
