## NDTSS/NANDTB/OA/01 (Issue 7) – Listing of Approved Outside Agency



The Criteria for assessment and NDTSS/NANDTB’s approval of Outside Qualifying Agencies is published in NDTSS/NANDTB/OA/02.

Organisations that have satisfied all prerequisites for approval under the scheme will be formally approved by NDTSS/NANDTB to deliver specified services, including the provision of NDT Level 3 services, and for qualification of NDT personnel against EN 4179, AIA-NAS-410 and other criteria.

This issue reflects the recommendations of the NDTSS/NANDTB to separately list the NDTSS/NANDTB approved Outside Qualifying Agencies. Outside agencies are required to fully satisfy NDTSS/NANDTB criteria for approval of training and examinations. All training and examination shall be conducted in English.
